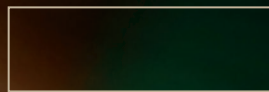

Our new Bariatric & Metabolic Institute is a comprehensive program that includes both minimally invasive procedures as well as non-surgical options. The Lung Center at Grand View Health tackles lung cancer and other complex lung conditions with advanced technology and fellowship-trained specialists. Our comprehensive women's health initiatives now include 3-D mammograms for breast cancer screenings. As part of the Fox Chase Cancer

Partnership, our cancer program includes advanced diagnostic techniques as well as talented surgeons so we can effectively treat these illnesses close to home.

These are just the first steps in providing more advanced treatments and technologies that will let us effectively treat the diseases and conditions right here in our community. The total power of healthcare technology has yet to be fully recognized, but we are actively involved in the cutting edge of technology as evidenced by our recent recognition as a Most Wired system by the American Hospital Association's Health Forum for the fifth consecutive year. We will continue to embrace emerging technologies and look forward to partnering with our patients as they become even more engaged in managing their healthcare.

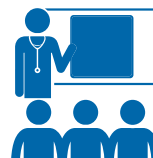

Health Checkup: Assessing the Needs of Our Community

Every year, residents from nearly 40 zip codes in Bucks and Montgomery counties choose to trust Grand View doctors, nurses and clinicians with their health and healing. Last year we provided care through 9,498 inpatient admissions, 7,087 surgeries and 33,069 emergency medicine visits. Our goal for more than 100 years has been to offer the most compassionate and advanced care close to home.

To ensure we are serving you the best we can, we periodically take a detailed look at the specific health challenges that face our community. This Community Health Needs Assessment, conducted by the Public Health Management Corporation (PHMC), starts with reviewing our interactions with patients and extends to consulting with the community, all to let us prioritize outreach, prevention, education and additional healthcare services

to meet the community's most pressing health needs.

In the last assessment, published in 2013, we identified several areas where Grand View could make a difference: women's health screenings (pap smears, mammograms and breast exams), annual healthcare provider visits, high blood pressure, binge drinking, childhood obesity, cancers, heart disease and stroke. Since then, Grand View has offered thousands of community education classes and increased awareness for health screenings.

As we begin the needs assessment process again, we look forward to identifying additional ways we can serve you and lead our entire community to a healthier future. ■



Advances in Bariatric Surgery and Metabolic Health

With one eye on clinical research and the other on growing concerns right here in our community, Grand View has paid close attention to obesity and related issues over the past several years. Awareness about this prevalent condition peaked when results from our 2013 Community Health Needs Assessment showed that more than one-quarter (28.8 percent) of adults in the Grand View service area were obese and more than one-third (35.1 percent) of adults were overweight.

To address this critical need, we established the Grand View Health Bariatric & Metabolic Institute, led by Michael Fishman, MD, in January 2015. Our team includes a bariatric surgeon,

patient navigator, physician assistant, exercise physiologist, registered dietitians and other support professionals to help patients through every step of their weight-loss journey.

The Institute is conveniently located at the Sellersville Outpatient Center and has a comprehensive program that includes both surgical and non-surgical options. Throughout the process, patients learn about nutrition, physical activity and the lifestyle changes necessary for attaining and maintaining weight loss. The first step for many patients is attending one of our free, monthly information seminars.

Dr. Fishman is a fellowship-trained bariatric surgeon and Diplomate of the American Board of Surgery with an extensive track record, having completed hundreds of bariatric surgeries in his career. He specializes in minimally invasive procedures for those who are interested in and qualified for surgery: Sleeve Gastrectomy, Gastric Bypass (Roux-en-Y) and Gastric Banding.

"Giving patients the hope and the reality of revitalized health and wellness has been my career's mission as well as my greatest reward," says Dr. Fishman. "I'm also grateful that our Institute now brings the latest developments in bariatric surgery and metabolic health to the very community I grew up in. It's a journey that has come full circle." ■

Dr. Watson has more than 17 years of surgical oncology experience and offers the most effective and up-to-date treatments. He specializes in a wide variety of solid tumor management, ranging from newly diagnosed common cancers to complex surgical options for pancreatic or liver cancers.

"We are committed to the highest quality of care for our patients, from diagnosis through treatment to post-treatment care," says Dr. Watson. "Our multidisciplinary team lets our patients stay close to home as we guide them every step of the way." ■

As the second most diagnosed cancer in both women and men, lung cancer claims more than 150,000 Americans each year, making it the leading cause of cancer death that impacts our friends, loved ones, neighbors and co-workers.

The Lung Center at Grand View Health, opened in April 2015, is dedicated to evaluating, diagnosing and treating lung cancer and other lung conditions using the most advanced technologies and treatment options. In addition, we offer comprehensive educational programs, support groups and screenings to promote healthy living and manage chronic disease.

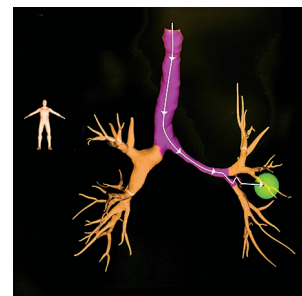

Nina Maouelainin, DO, director of The Lung Center, is the only fellowship-trained interventional pulmonologist in Bucks and Montgomery counties. Dr. Maouelainin is leading a multidisciplinary team that works with the latest diagnostic technology for early detection and diagnosis of cancer, including:

- **Endobronchial Ultrasound (EBUS)** is an effective minimally invasive procedure for diagnosing and staging lung cancer by sampling tissue and lymph nodes for pathologic evaluation.
- **Electromagnetic Navigation Bronchoscopy (superDimensional ENB)** allows physicians to navigate to pulmonary nodules even in the most difficult to reach areas of the lung to aid in the diagnosis and early treatment of lung diseases. Both the EBUS and the superDimensional ENB procedures carry significantly less risk than traditional diagnostic methods.
- **Low-Dose CT Screening** is a quick, safe and painless way to screen people at high risk for lung cancer: current or former smokers from 55 to 74 years old whose smoking habit was at least one pack per day for 30 years or more. This screening has been proven to detect lung cancer better than traditional X-rays.

In addition to these diagnostic procedures, The Lung Center also offers laser therapy and stent placement in the airways.

Together, our Lung Center team and our technologies offer our patients effective diagnostic and treatment options closer than ever to home. ■

Advances in Breast Care

At Grand View Health, our Breast Imaging Center screens more than 15,000 women annually. Based on our 2013 Community Health Needs Assessment, 45 percent of women over 40 in our service area are not receiving annual mammogram screenings.

Breast care is a top priority for Grand View Health, designated a Breast Imaging Center of Excellence by the American College of Radiology (ACR). We are fully accredited in mammography, stereotactic breast biopsy, breast ultrasound and ultrasound-guided breast biopsy—all designed to detect cancer at the earliest stages.

In April, Grand View expanded its imaging program to include 3-D mammography screening using its new GE SenoClaire Digital Breast Tomosynthesis (DBT) System. By leveraging this advanced technology, David Levin, DO, chief mammographer, is able to provide patients with:

- Enhanced imaging of dense breast tissue
- Improved detection of cancer
- Lower biopsy rates
- The lowest dose of radiation in the industry
- The highest level of patient care and comfort
- A reduced need for follow-up imaging

Imaging is just one facet of our breast care program. Our multidisciplinary approach combines enhanced patient education, aggressive treatment options, comprehensive therapy services and supportive staff. A Breast Care Navigator facilitates continuity of care, making the diagnostic and treatment process as smooth as possible.

Because every patient's breast cancer is unique, diagnostic genomic analysis has become an important tool to help guide treatment options for early stage disease. Grand View currently offers the Oncotype DX diagnostic test, which helps us individualize treatment planning, including determining which patients can benefit from chemotherapy in addition to hormonal therapy. In addition, we help high risk patients further explore cancer risk

assessment and genetic counseling options to determine if they are at risk for familial or hereditary breast cancer syndromes.

Other important advances in breast cancer are in the realm of surgery. We recently welcomed Monique A. Gary, DO, an experienced breast surgical oncologist. Fellowship-trained in a variety of breast surgical oncoplastic options, Dr. Gary takes a breast-conservation approach to her surgery whenever possible, such as nipple-sparing mastectomies and providing better overall cosmetic outcomes for patients.

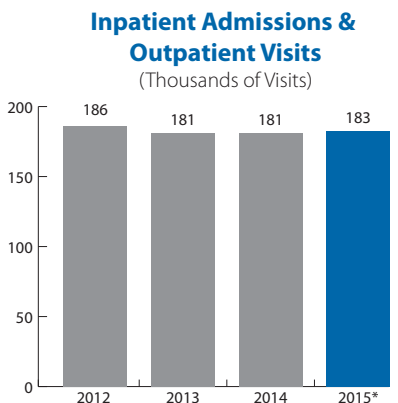
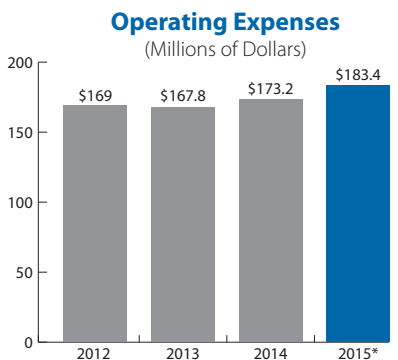
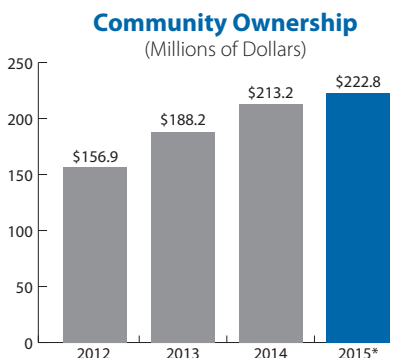
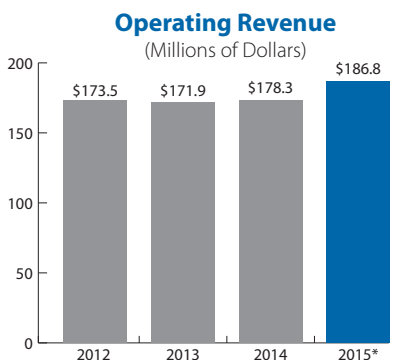
"When a woman has an abnormal mammogram and is referred to me by one of our radiologists, quite often she may not require surgery. Rather, it's a chance to educate her about her specific breast concerns, screen for risk factors, perform a clinical exam and explain confusing results and the possible need for ongoing surveillance," says Dr. Gary.

"If surgery is required," she continues, "there is a wider range of breast reconstruction and surgical techniques than ever before, so concerns about physical disfigurement and scarring associated with a diagnosis of breast cancer are now a thing of the past."

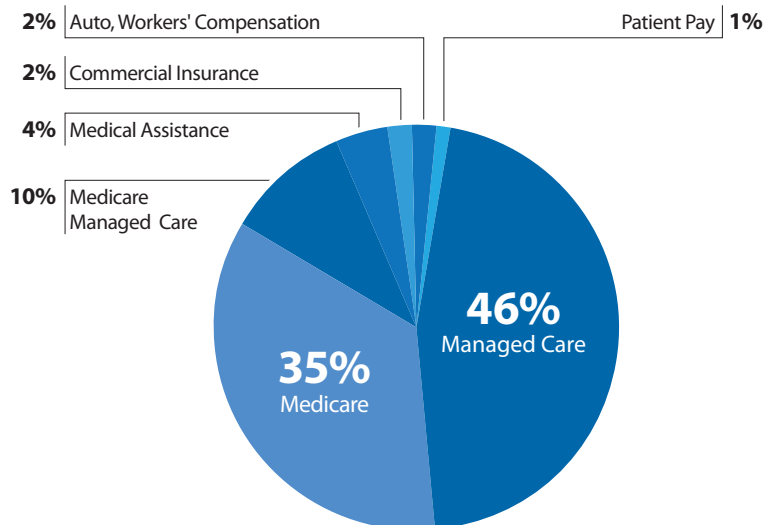

- **Disaster Preparedness** – As a regional medical center that continued to provide life-saving healthcare services during Hurricane Sandy's five days of power outages, our facilities also helped area residents, who came to our cafeteria for a hot meal, Wi-Fi access, and to charge their cell phones. By upgrading our electrical backup system, we will be even better prepared to support our community as a regional resource in the event of future disasters.



- **Community Services** – From childbirth preparedness to our safe driving for seniors programs, Grand View offers more than a hundred classes every year. Frequently these programs are offered in our Community Education Center, which has resided in temporary classrooms behind the hospital for 10 years.
