

# John's Story Vascular Surgery

Without any warning, piercing abdominal and back pain forced 69-year-old John Defeo to fall to the floor and dial 9-1-1 from his home. He was brought to the Grand View Health Department of Emergency Medicine, where Dr. Christopher Ricci performed a clinical evaluation and ordered an immediate CAT scan. The diagnosis was life-threatening: a ruptured abdominal aortic aneurysm that grew to be four-inches wide.

Within minutes of his scan, John was transported to the operating room, where Vascular Surgeon, Eric V. Olivero, MD, was awaiting his arrival. Every minute was critical because John was about to undergo one of the most fatal surgical emergencies. Knowing that roughly one in ten people survive a ruptured abdominal aneurysm, Dr. Olivero successfully performed life-saving surgery to stop the bleeding and repair it using minimally

invasive techniques. John continues on the road to recovery as he reflects and appreciates the life he is so lucky to live.

"I don't remember too much after I collapsed from the pain," said John. "But, I will never forget the way I was treated by all of the people at Grand View. They saved my life."

# Kelly's Story

When Kelly Jerrom went to her family doctor for what she thought were flu symptoms, she never imagined that several days later she would be in a medically induced coma and on life support. But the 38-year-old mother of four-year-old twin girls spent four weeks in the intensive care unit at Grand View Health for a bacterial infection that rapidly turned into severe septic shock, a life-threatening condition. When a CAT scan revealed brain swelling, she was flown to a Philadelphia hospital where she stayed for two more weeks.

After a week of physical therapy, she finally returned home following a seven-week long emotional roller coaster ride. "As soon as we thought she was recovering, her vitals plummeted and we were back against the edge of the cliff," said Peter, Kelly's husband. "Through it all, though, the staff at Grand

View went above and beyond. Doctors and nurses who weren't even handling Kelly's case offered to help. So many little things became a collective big thing."

Kelly's care was orchestrated by a caring multidisciplinary team that met daily. "Kelly wasn't just room 10 to us," said Evan Lenkowsky, DO, Grand View critical care medicine specialist. "The entire team did a fantastic job. We may be a small hospital, but we have processes in place to provide the highest level care, even for the sickest of the sick."

Now on her way to a full recovery Kelly says, "I say a silent thank you to Grand View every day for saving my life."

# Oy's Story Breast Cancer

At the time, Joy Brauer, a 35-year-old mother of three, didn't think the achy feeling in her left breast would lead her to meet with Breast Surgical Oncologist, Monique A. Gary, DO. After all, she was hopeful the pain had something to do with her menstrual cycle. To be safe, she followed her OB-GYN's recommendation and had a mammogram and ultrasound.

Nothing was found in her left breast; however, a small cluster of calcifications was seen in her right breast, which in Joy's case indicated early stage breast cancer. Given her young age, Joy decided to undergo a bilateral nipple-sparing mastectomy and immediate reconstruction with Dr. Gary. Three small yet significant reasons all under the age of seven helped her arrive at this decision — her children Samuel, Julia and Benjamin.

Four months after surgery, Joy walked down the aisle in her sister's wedding and marched forward in life with confidence in her health and a bright future with her family.

"My kids were on my mind throughout this entire journey," recalled Joy. "I would like to encourage other women to listen to their bodies and get their mammograms. Most of all, live life fully and hug your kids a little longer each day, because you never know what tomorrow will bring."

# Jack's Story Orthopaedics

When Denise Kane heard the crash, she immediately ran to find her 24-year-old son Jack lying on his bedroom floor in shattered glass. The uncontrollable movements of an epileptic seizure had thrust him into a wall of framed photos. Jack was rushed to Grand View Health's Department of Emergency Medicine, where he was treated for lacerations. James Hurley, MD, of Upper Bucks Orthopaedics and Sports Medicine, was also able to manipulate his dislocated shoulder back into place without surgery.

With two months of physical rehab ahead of him, Jack wouldn't be able to swim or care for his horses, his two main passions. Jack has ridden therapeutic horses since he was 5 years old, responding so well that his family moved to a 10-acre Montgomery County farm, along with three horses, several cats and two dogs. Since then he has earned numerous horse

show ribbons for riding therapeutic horses and is an able-bodied rider showing horses at the Garden State Paint Horse Club.

Following a full recovery, Jack was able to help stack 174 bales of hay and went on to win gold and bronze medals in Pennsylvania's 2016 Special Olympics swimming competitions.

"Because of Jack's epileptic condition, we jokingly refer to our family as Grand View frequent flyers," quipped Denise. "We've been to the ED countless times and always have wonderful care. Dr. Hurley, too, was so calm and competent, which is exactly what we needed in a time of crisis."

# Janessa's Story Bariatric Surgery

**Enough was enough** for Janessa McCracken. The 35-year-old insurance agent weighed 300 pounds and had tried everything to lose weight on her own through diet and exercise. Nothing worked. Her motivation dwindled with each passing day. Yet she longed to have a more active lifestyle and the chance to have a baby with her husband, Jim, with whom she has three stepsons.

Janessa's primary care physician suggested bariatric surgery as a way to lose excess weight and improve her overall health. From the moment she met Grand View Health Bariatric Surgeon, Michael K. Fishman, MD, at the hospital's free informational seminar, Janessa knew he was going to change her life.

She qualified for surgery and underwent a sleeve gastrectomy on Nov. 18, 2015. Eight months after her procedure, Janessa was exercising regularly, adjusting her diet, and enjoying a new outlook on life, all while losing 120 pounds. She decided to pay it forward by helping others who struggle with obesity-related issues by writing a blog chronicling her personal journey.

"People come into your life for a reason," Janessa said. "Because of Dr. Fishman and the bariatric team, I have new confidence, more energy and endless possibilities. They helped me press the restart button. I feel this need to help others do the same."

# Diane's Story

In the last year, 56-year-old finance professional Diane Kovacs has had a lot to be thankful for. After enjoying Thanksgiving dinner with family in 2015, Diane didn't feel well and knew something was wrong. Soon after, she had her husband drive her to a nearby hospital, where a CAT scan revealed a tumor in her left lung. At that moment, Diane was referred to her lifeline and her biggest patient advocate, Nina Maouelainin, DO, interventional pulmonologist at Grand View Health.

Dr. Maouelainin was Diane's trusted guide on this unexpected journey. Using the latest diagnostic technology for detection and identification of lung cancer, Dr. Maouelainin performed an Electromagnetic Navigation Bronchoscopy, navigating through Diane's airways to locate the tumor. She then used an Endobronchial Ultrasound to get accurate

samples of the lung tissue and lymph nodes. The tests confirmed that the 30-year smoker had stage 3A lung cancer.

Through physician collaboration, Diane's treatment plan was mapped out for chemotherapy, radiation and surgery. Dr. Maouelainin ultimately referred Diane to a skilled thoracic surgeon in the region who removed her left lung and saved her life. Two months later, Diane was cleared to go back to work to crunch numbers and count her blessings.

"I don't know what I would have done if Dr. Nina's name had not come up," Diane reflected. "She gives you hope, compassion and assurance that your diagnosis is a journey and that no matter what, you wouldn't be alone. I owe my life to her."

With six children and 24 grandchildren, the former principal of the school, longtime history teacher, student greeter, coach, volunteer and woodworker rarely sits. So when he began having difficulty walking, climbing steps and scaling his hillside property, he knew it was

time to consider a bilateral knee replacement.

He scheduled the double knee replacement at The Joint Center at Grand View Health in June with the goal of starting the new school

year without pain. "After the surgery, I was on my feet within hours, out of the hospital in a day, and walking without a cane in just four weeks," said Robert. "I can't say enough about the whole team. From the nurses and therapists to Dr. Weidner, everyone was fantastic." He attributes his quick recovery to the great care he received and being diligent about doing all of the recommended pre- and post-surgery exercises.

Just two months after his surgery, Robert started the 2016-17 school year standing at the school entrance to greet and high-five students welcoming them warmly for a new year full of possibilities.

## Top Health Challenges Facing the Grand View Health Service Area

**Some of the top health challenges facing our community** today are obesity, diabetes and cardiovascular disease, according to a three-year Community Health Needs Assessment\* conducted by the Public Health Management Corporation (PHMC). The report identifies and prioritizes community health needs, which help Grand View develop strategies that benefit the public, and satisfy the requirements of the Affordable Care Act.

These findings have provided Grand View Health with insights about the impact that lack of exercise, poor diet and smoking have had on local and national communities. While 86 percent of people in the Grand View Health service area—comprised of Bucks and Montgomery counties—are in excellent or good health, 14 percent are in fair or poor health.

Over the next three years, Grand View will offer a variety of educational programs to address the challenges identified in this report. The good news is that we are all in this together and it's never too late to start living a healthy lifestyle.

**OBESITY** 

Obesity is the second most frequent cause of death in our service area, resulting in 82 deaths per 10,000 people annually.

**DIABETES** 

About **14,100** adults, or 8%, have been diagnosed with diabetes in our service area.

**CARDIOVASCULAR DISEASE** 

Coronary heart disease is responsible for 82 deaths annually per 100,000 population in our service area.

**LUNG DISEASE** 

Lung cancer is responsible for 36 deaths per 100,000 population annually, and is the leading cause of death due to cancer in our service area.

**CANCER:** PREVENTION, **SCREENINGS** AND SERVICES

In our service area 35% of women age 18 and older did not have a clinical breast exam in the past year; 14% of women 50-74 did not have a mammogram in the past two years; and 35% of men and women age 50 and older did not have a colorectal exam.

**BEHAVIORAL HEALTH** 

Approximately 24,900 adults, or 14%, have been diagnosed with a mental health condition in our service area.









